## Description:

As required under section 76.1 (a) of the Freedom of Information and Protection of Privacy Act, the Board of Education designates the Superintendent to be the official head of the school district for the purposes of the Act.

As permitted under section 76.1 (b) of the Freedom of Information and Protection of Privacy Act, the Board authorizes the Communications Officer for the District to be the Information and Privacy Coordinator (IPC) who will administer the Act and make operational decisions.

### Description:

The following schedule outlines the responsibilities of the Superintendent/CEO (Head) and the Communications Officer/Information and Privacy Coordinator (IPC) in regards to the Freedom of Information and Protection of Privacy Act.

The IPC for School District #59 shall be the Communications Officer (IPC-D) for the District, the Personnel Manager (IPC-P) for Personnel Records and the Secretary Treasurer (IPC-F) for Financial Records. For Transactions that identify only IPC all three will perform the function within the areas of their responsibility.
