Class Size & Composition Report

There are seven schools not in compliance with class size and/or composition maximums as describe in LOU # 17. A meeting occurred with the union president of the PRSTA to report on our best efforts to resolve any class size or composition issues. The union president agreed the district had demonstrated best efforts and supported applying remedies in classrooms that are over class size and/or composition maximums.

Montessori School Review

Additional details of the Don Titus Montessori School review were discussed. The intent of the review for Don Titus is to ensure the Montessori program is operating in accordance with Montessori principles. As a school of choice with a Montessori program, it is important the Board of Education have the confidence in supporting and recognizing the program is authentic and sustainable. The process for the review was explained, additional details were included in the board package.

Final Enrolment

The final enrolment for the 2018/19 school year is 3639.25 FTE which is an overall increase in 86.63 FTE.

Executive Compensation Disclosure

The compensation paid to executive staff for the 2017/18 fiscal year was presented. The Executive Compensation Report is available on the district website under district info, financial information.

SOFI Report

The SOFI report describes financial information in the district and includes the audited Financial Statements, schedule of remuneration and expenses, a listing of all employees earning over \$75,000 and suppliers receiving over \$25,000. Chetwynd Proposed School Closure Update

In past school closure processes the first and second reading of the bylaw have occurred in October as indicated in the September board meeting. The Secretary Treasurer discussed how the proposed school closure review for Don Titus Montessori is a more complex situation and that more time is going to be needed to gather data to determine if a recommendation for the first bylaw reading for school closure will be brought forward or not. No timelines have been set as it will depend on the data received, as well as, time required to educate the new board that was recently elected. While this process can be upsetting for students, staff, parents and the community is it important there is enough time taken for a thorough review.

School Review/ Closure Process

Trustee Ziemer recommended that the School Closure policy and regulation be referred to the policy committee to determine if improvements can be made to the process, taking into consideration the letters received from concerned Don Titus parents.

Crosswalk safety

Trustee Smith discussed safety concerns with the crosswalk on Highway 97 by Chetwynd Senior Secondary and Windrem Elementary. Transportation Manager, Jeff Lekstrom, has already spoken to RCMP with the request to increase police presence around the crosswalk during pivotal times. Additional recommendations were presented that are being considered.

Superintendent Contract

Superintendent, Candace Clouthier, has agreed to extend her one-year contract for an additional year, it will end after the 2019/2020 school year.
